

**THE OOIDA 50TH ANNIVERSARY SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

ELIGIBILITY: This Sweepstakes is not open to the general public. The Sweepstakes is only open to current Commercial Driver’s License holders who are owner/operators and/or fleet owners that are legal residents of the 48 contiguous U.S. or D.C. (excluding Alaska and Hawaii), ages 21 and older at the time of entry. Void in Alaska, Hawaii, Puerto Rico, Guam, the U.S. Virgin Islands, outside the U.S., and wherever else prohibited by law. Employees of Owner-Operator Independent Drivers Association (“OOIDA” or the “Sponsor”), US Sweepstakes & Fulfillment Company (the “Sweepstakes Administrator”) and their respective subsidiaries, affiliates, advertising and promotion agencies, and the immediate family members (spouses, parents, children, and siblings and their spouses) of, and/or those living in the same household of each, are not eligible to enter. Within the Sweepstakes Period, there are three (3) Entry Periods (each, an “Entry Period”) and three (3) corresponding Random Drawings (each, a “Drawing”) as defined in the “Entry Periods & Drawings Schedule” below. Entries must be received during an Entry Period to be eligible for that Entry Period’s drawing and prize. Non-winning entries for an Entry Period will not roll over to subsequent Entry Periods. Sponsor’s computer is the official timekeeping device for this Sweepstakes.

HOW TO ENTER: There are six (6) ways to enter.

Method #1: Online Entry. During the Sweepstakes Period, visit www.OOIDASweepstakes.com and follow all entry instructions to complete the entry form and submit to receive one (1) entry into the Monthly Prize drawing for the corresponding Entry Period and one (1) entry into the drawing for

the Grand Prize (the “Online Entry”). Participants may earn additional entries if they are an OOIDA Insurance, Life and Health, or CMCI Customer or Truckers Advantage Fuel Card account owner as indicated in Entry Methods 3 and 4 below. Online Entry form may only be submitted one (1) time per person during each Entry Period.

Entry Method #2: Membership Entry: During the Sweepstakes Period, participants who renew or purchase an OOIDA membership to receive one (1) entry into the Monthly Prize drawing for the corresponding Entry Period and one (1) entry into the drawing for the Grand Prize (the “Membership Entry”).

Entry Method #3: OOIDA Customer Entry: During the Sweepstakes Period, participants who are OOIDA insurance customers, OOIDA Life and Health customers or OOIDA CMCI customers at the time of entry may check the box indicating each on the Online Entry to receive one (1) entry into the Monthly Prize drawing for the corresponding Entry Period and one (1) entry into the drawing for the Grand Prize (the “Customer Entry”) for each box checked. Customer Entries are subject to verification.

Entry Method #4: Fuel Card Entry: During the Sweepstakes Period, participants who are owners of a Truckers Advantage Fuel Card account (the “Fuel Card Account”) in good standing at the time of entry must complete the following steps to earn three (3) entries into the Monthly Prize drawing for the corresponding Entry Period and three (3) entries into the drawing for the Grand Prize (the “Fuel Card Entries”):

1. At the time of submitting an Online Entry, check the box indicating they would be an account owner of a Fuel Card Account; and then

Fuel Card Entries will be earned by the Fuel Card Account owner regardless of the individual making or card used for such purchase. Participant's name and email address on submitted with the Online Entry must match the account owner records for an active Fuel Card Account. **Limit: Three (3) Fuel Card Entries per person per Entry Period regardless of the number of purchases made.**

Method #6: Free, Alternate Method of Entry / Mail-in Entry. Online Entry, Membership Entry, Insurance Entry and Instagram Entry collectively referred to herein as "Entry" or "Entries". **Limit: Seven (7) Entries per person per Entry Period regardless of the method of entry.** All methods of entry have an equal chance of winning. All entries become the property of the Sponsor and will not be acknowledged or returned.

- Entry and Photo cannot communicate messages or images inconsistent with the positive images and/or goodwill to which Sponsor and Instagram wish to associate.
- Entry and Photo cannot depict illegal activity and cannot itself be in violation of any law.
- Entry and Photo cannot in any way reference persons or organizations without written permission from any person or organization whose name or likeness is used.

PRIZES/APPROXIMATE RETAIL VALUE (“ARV”)/ODDS:

Monthly Prizes: There are three (3) Monthly Prizes available to be won. Each Monthly Prize winner will receive one (1) OOIDA prize package (contents to be determined by Sponsor). **The ARV of the Monthly Prize: \$250 each.**

Grand Prize: There are two (2) Grand Prizes available to be won. Each Grand Prize winner will receive one (1) \$5,000 OOIDA/WEX Truckers Advantage Fuel Cards. **The ARV of Grand Prize: \$5,000 each.**

The total ARV of all prizes available to be won: \$10,750.

There is a limit of one (1) Monthly Prize per person. Odds of winning a Monthly Prize will depend upon the total number of eligible entries received per Monthly Entry Period. Odds of winning the Grand Prize will depend upon the total number of eligible entries received during the Sweepstakes Period.

RANDOM DRAWINGS: Random Drawings will be conducted by the Sweepstakes Administrator, an independent representative of the Sponsor, whose decisions are final. The potential Monthly Prize winners will be selected in a series of random drawings from among all eligible entries received within the corresponding Entry Period on or about the corresponding Random Drawing Date indicated in the Entry Periods & Drawings Schedule in the “Sweepstakes Entry Periods” section of these Official Rules. The potential Grand Prize winner will be selected in a random drawing on or about **Tuesday, November 7, 2023**, from among all eligible entries received during the Sweepstakes Period.

WINNER NOTIFICATION: In the event a potential Grand or Monthly Prize winner entered via Instagram Entry, such potential winner will be notified by Sponsor via direct message to their public Instagram account (the "Initial Notification"). To begin the prize claim process, a potential winner must respond as instructed to the Initial Notification with his/her full name, home address and email address within 48 hours of the Initial Notification. Any potential prize winner who does not reply to the Initial Notification with the required information and within the specified time period will be disqualified and an alternate winner will be notified. If Sponsor is unable to determine and verify a potential winner after repeated alternate drawings or if Sponsor fails to receive a sufficient number of entries to correspond to the number of prizes available to be awarded, Sponsor reserves the right to not award such prize(s). Prizes will be sent to the address provided via email within 4-6 weeks of winner being verified.

PRIZE CONDITIONS: Prizes are not redeemable for cash, assignable, transferable and may not be substituted except at Sponsor's sole discretion. Sponsor reserves the right to substitute a prize of equal or greater value at its discretion. Any other incidental expenses on prize not specified herein are the winner's sole responsibility.

Prepaid/gift cards are not redeemable for cash and will not be replaced if lost or stolen. Prepaid/gift card usage is subject to the issuing company's complete terms and conditions, including expiration dates.

Winner is responsible for all federal, state, local and income taxes associated with winning prize. Grand Prize winner will be required to furnish their Social Security Number for the sole purpose of preparation of tax forms as required by law.

DISPUTES: The parties hereto each agree to finally settle all disputes only through arbitration; provided, however, the Released Parties shall be entitled to seek injunctive or equitable relief in the state and federal courts in Jackson County, MO and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action
